As the European Institution representing cities and regions, the European Committee of the Regions (CoR) has prioritised engaging citizens in the discussions on the future of Europe.

In order to continue and deepen these discussions, this event is an opportunity for members of the CoR and other high-level leaders of EU towns, cities and regions to share their views on some of the main policy areas in the discussion on the Future of Europe.

The presidents of national associations of local and regional authorities are invited to an opening meeting with the president of the CoR and the president of the CEMR (Council of European Municipalities and Regions), followed by three round-table thematic discussions, focused on three policy areas and six sub-themes.

In the afternoon, they are invited with all the other presidents of the national associations to attend the plenary session of the European Committee of

the Regions in the Hemicycle of the European Parliament where major challenges of the towns, cities and regions in the European Union will be discussed.

All national associations are invited to submit, prior to the event, any documents or policy papers on the future of Europe they might have adopted.

Journalists from national media are invited to follow the event and report on the input of their national representatives.

European Committee of the Regions

Created in 1994 following the signing of the Maastricht Treaty, the European Committee of the Regions is the EU's assembly of 350 regional and local representatives from all 28 Member States, representing over 507 million Europeans. Its mission is to involve regional and local authorities and the communities they represent in the EU's decision-making process and to inform them about EU policies. The European Commission, the European Parliament and the Council are obliged to consult the Committee in policy areas affecting regions and cities. It can appeal to the Court of Justice of the European Union if its rights are infringed or it believes that EU law infringes the subsidiarity principle or fails to respect regional or local powers.
